



EXCLUSION OF LIABILITY AND INDEMNITY

PAKLAND SERVICES Canada, located at 3025 Hurontario St. Mississauga, ON, its officers, director, employees is in Tour Package and tourism services , and where as you are entering into a legally binding agreement with PAKLAND SERVICES who provide you with the Services, and whereas you confirm that you have been advised by PAKLAND SERVICES that you recognize that PAKLAND SERVICES does not own, manage, control or operate any transportation vehicle, hotel, resorts restaurants or other supplier and is not responsible for their acts or omissions.

Now therefore in consideration of PAKLAND services providing the Services, I agree as follows:

1. PAKLAND SERVICES shall not be responsible for, or assume liability in connection with, any loss, damage, expenses or injury, whether physical or mental, resulting from any delay, or any act, mission, negligence or commission of any party supplying any of the services or accommodations to its agent, servants, employees, subcontractors or for any claims for such loss, damage or injury, whether physical or mental, arising there from or from any cause that arises by reason of actions of parties other than PAKLAND SERVICE. Without limiting the generality of the foregoing, PAKLAND SERVICES shall not be responsible for, or assume liability in connection with, any injury, damage, death, loss, additional expenses or accidents suffered by me, in any manner whatsoever including as a result of defects in any vehicle, or thought the acts or defaults of any company or person engaged in transporting me.

2. PAKLAND SERVICES shall not be responsible or liable in connection with any losses or additional expenses occasioned by me as a result of the acts of God, delay or changes in schedules overbooking or sickness, weather, strikes, war, quarantines, epidemics, pilferage, customs or immigration regulations or other acts or circumstances in this connection beyond PAKLAND SERVICES reasonable control.
